



# ASSISTING LACKAWANNA COUNTY FAMILIES AND INDIVIDUALS WITH SAFE AND AFFORDABLE HOUSING SINCE 1961

The Housing Authority of the County of Lackawanna will open its Housing Choice Voucher waiting list beginning **May 2, 2022** and will close the waiting list on **May 27, 2022**. This will be for eligible individuals and families who are in need of rental assistance within HACL's jurisdiction. HACL's jurisdiction includes all boroughs and townships within the Lackawanna County lines, EXCEPT for Scranton and Carbondale, which have their own Housing Authorities. To be eligible for housing assistance, your total income must not exceed the maximum income limits established by the U.S. Department of Housing and Urban Development.

ANY APPLICATION POSTMARKED AFTER May 27, 2022 WILL NOT BE ACCEPTED.**

**ALL QUESTIONS ON THE APPLICATION MUST BE ANSWERED AND SIGNED BY ALL HOUSEHOLD MEMBERS 18 YEARS OF AGE OR OLDER.**

**ANY FORMS RECEIVED THAT ARE INCOMPLETE WILL NOT BE ACCEPTED OR RETURNED. NO EXCEPTIONS.**

**IF YOU SELECTED THE PREFERENCE FOR DOMESTIC VIOLENCE OR VETERANS STATUS; YOU MUST PROVIDE THE SUPPORTING DOCUMENTATION WITH YOUR RETURNED APPLICATION.**

Applicants who are already on the waiting list for other housing programs, and are interested in applying for the HCV program, must complete a new application. You will not lose your place on the other waiting list(s).

Persons with disabilities who require a reasonable accommodation in completing an application, may call HACL to make special arrangements. A Telecommunication Device for the hearing impaired (TDD) is available for a hearing impaired person.
